7.REPORT ON THE MEETING WITH THE ENVIRONMENT AGENCY, ERY COUNCIL, LANDOWNERS AND PARISH COUNCIL – 26 June 2017.

**Flooding and the riverbank** -The Clerk to collate as much information about the flooding in 1953 and any effect this had on Gilberdyke. There is no archive held by the Environment Agency. The report regarding work on the river bank will be started in 2018, with the next meeting of interested parties being held in December 2017.

**Pumped station** – The land in Blacktoft where the pumped station is to be sited has been cleared so that the over head cables can be re-sited below ground. The work on the Eastrington pumped station at Cotness (Laxton Parish) has started.
